Breeding Contract for the KFPS Approved Breeding Stallion Bene 476 owned by Carolyn Schian (óStallion Ownerö) standing at Signature Friesians Stallion Station.

This Breeding Contract is made between Signature Friesians LLC (óstallion stationö) and _____ (ómare ownerö) on this date _____, 2014.

The following FPS/FHANA registered mare known as _____, with the reg# _____ to be bred to the FPS Approved Stallion Bene 476, with the following terms and conditions for the 2014 Breeding Season.

1. Breeding season for Bene 476 will be from March 1st thru August 31st, 2014. Bene 476 will be offering Fresh Cooled Semen only through AI.
2. All Breeding Fees (*unless a Breeding Fee Payment Plan agreement has been approved*) and Collection Fees are to be paid before semen is shipped **for each mare**. No semen will be shipped unless a breeding fee has been pre-paid for the mare the semen is being shipped for or *unless a Breeding Fee Payment Plan agreement has been approved for each mare*. If semen is used for a mare not provided in this agreement you must immediately inform Signature Friesians Stallion Station and pay the breeding fee for that mare. Payment can be made by check, Visa, MasterCard, Discover or American Express. Mare owner must provide Signature Friesians LLC with a current credit card at all times in order to cover possible charges.
3. No semen will be shipped for any mare that has not provided us with a signed agreement.
4. Bene 476 to be bred to FPS Registered Mares only and semen to be used on only the mare provided in this agreement. This agreement can not be transferred or sold by mare owner unless permission is given by Signature Friesians LLC.
5. Mare owner is to provide Signature Friesians LLC with a copy of Mare's registration papers and also fill out information page at the end of this agreement.
6. Breeding Fee to be \$1500.00 for Bene 476.
7. Multiple mare discounts are given after the first mare. Each mare after the first at normal price will receive a \$200.00 discount. Mix-n-match your stallions, this can be used between all stallions standing at Signature Friesians Stallion Station.
8. Signature Friesians LLC assumes no responsibility for the loss of semen or semen viability caused by the carrier (FedEx). There will be no shipments on Saturday, Sundays, Holidays or leading into a Holiday where FedEx is unavailable for overnight delivery.
9. Collection days will be Monday thru Friday. Please call Barn number to order semen 785-594-3012. The collection fee will be \$225.00 plus FedEx standard overnight shipping. Semen request are to be made by 12:00 pm CST on the day of collection. As we may not be collecting everyday, please give as much notice as possible.
10. Each shipment will contain one dose and only if all orders are filled and additional doses are available will there be a second dose included.

11. In most cases disposable shipping boxes will be used for 2014. If for some reason we run out of shipping boxes and must use the Equitainers, these shippers must be returned within 7 days or \$10.00 per day will be charged. It is recommended that mare ownerø insure Equitainers for \$300.00. A charge to mare ownerø credit card of \$300.00 will be made for a loss or damaged shipping container.
12. Canada shipments will be subject to extra cost of \$165.00 due to CFIA Regulations.
13. Embryo Transfers are only allowed with the permission of Signature Friesians LLC.
14. The Mare owner will be given a Live Foal Guarantee which is defined as a newborn foal able to stand and nurse without assistance. Notification of loss either through absorption or death must be given to Signature Friesians LLC within 10 days of loss by a licensed Veterinarian. Mare owner will receive a return privilege for the following breeding season.
15. Mare owner will receive a Breederø Certificate directly from FHANA. Please contact us or the FHANA office if you do not receive your certificate. You should receive certificates around February following the breeding season.
16. Mare owners must confirm for pregnancy approximately 15 days after ovulation and again at 45 days. Mare owner must make Signature Friesians LLC aware of the results.
17. Stallion service will be provided only to healthy mares in sound breeding condition, as determined by a licensed veterinarian acceptable to Signature Friesians LLC. A breeding soundness exam is strongly recommended prior to shipping semen. Mares should be bred immediately upon shipment under the guidance and supervision of a licensed veterinarian. If the Mare has been open, Signature Friesians LLC may require the submission of a recent uterine culture certificate. If the Mare fails to settle after two cycles, Signature Friesians LLC may require the Mare Owner to obtain a current reproductive exam and uterine culture prior to any further shipments. Signature Friesians LLC cannot be held responsible in any way for any illness or injury to a mare or to any other horse due to breeding to Bene 476, nor for a mareø failure to conceive.
18. Mare owner shall not be entitled to a refund of fees paid hereunder except if the stallion should die or become unfit for service prior to serving the mare in the present breeding season.
19. This *Breeding Contract* must be in writing, and the parties agree that a fax copy or printable email version of the contract shall qualify as a öwritingö.
20. This contract shall be governed by the law of the state of Kansas and shall be binding upon the parties hereto and their personal representatives.
